- Check with operator going off duty to see what grade is being made, the nature of the process for that day and what is being pumped
- Change amp charts as required, monitor pipeline pressure
- Designate grades stored in each tank and record tank levels
- Check blunger and screen residue
- Monitor separator pause dump cycles and adjust separators as needed
- Monitor screens to prevent screen runoff
- Keep loaders and mill equipment greased
- Check and record calibration of chemical flow meters and roto-meters once per week
- Make visual inspection of mill each shift, record and notify supervisor of problems
- Pump clay as ordered by classifying
- Check ton per hour, pH, solids and chemical dosages on all eight blungers every two hours
- Place sample buckets and required points and ensure samples are caught according to procedure
- Check pipeline sample every two hours
- Keep check on waste pond water level behind washer mill
- Keep check on sand pumps to make sure water addition is sufficient to prevent waste line stop-ups
- Compare density meter solids to flask solids once per shift
- Keep mill equipment greased and mill area safe, clean and ensure good housekeeping
- Perform pre-shift and work area inspections
